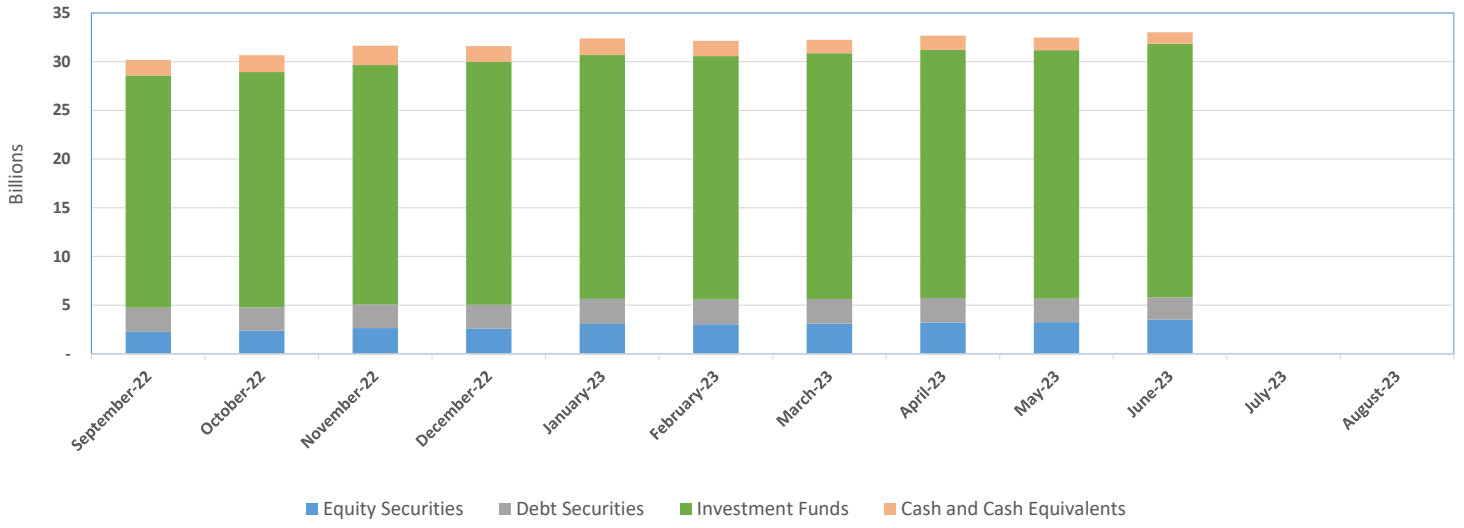


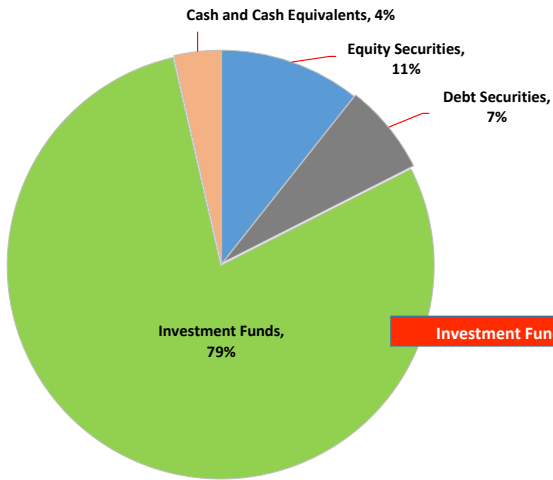

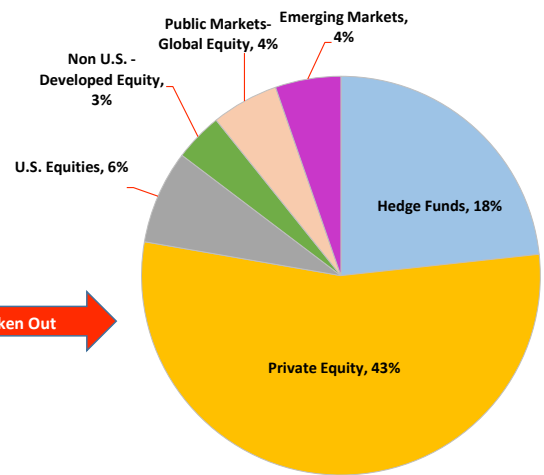
Investment Portfolio - FY 2023



Investment Portfolio as of June 2023

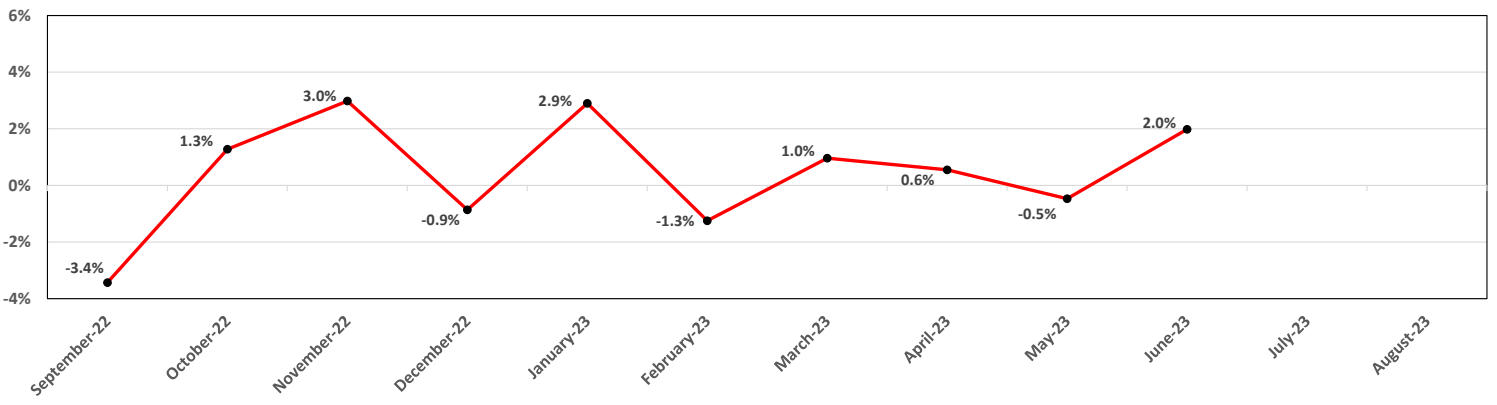


Investment Funds Breakout
