As required by the General Appropriations Act of the 80th Legislature, Regular Session, Article III-42, Section 6(b), attached is the Fiscal Year 2008 Report of Higher Education Employees Group Insurance Contributions Appropriations Transfers for The University of Texas System. Appropriations have been or will be transferred in the near future. U. T. institutions were unable to meet their full proportional funding needs. In order to fully fund the general revenue proportion, an additional \$10.1 million of appropriations would have been required.
