1. U. T. Dallas: Appointment of Dr. Robert H. Rutford as President Emeritus

RECOMMENDATION

Chancellor Yudof concurs in the recommendation of President Daniel that authorization be granted to appoint Dr. Robert H. Rutford as President Emeritus at U. T. Dallas. Approval of this recommendation is being requested in accordance with the Regents' *Rules and Regulations*, Series 20301.

BACKGROUND INFORMATION

Dr. Robert H. Rutford served as President of U. T. Dallas from 1982-1994. He was the initial holder of the endowed Excellence in Education Foundation Chair Number 1 and served as Professor in the Department of Geosciences until his retirement in Spring 2007.

Under Dr. Rutford's presidency, U. T. Dallas expanded to include a lower division of freshman and sophomore students and the first on-campus student housing was developed. In addition, Dr. Rutford provided direction and support for the founding of the Erik Jonsson School of Engineering and Computer Science.

Dr. Rutford, a renowned scientist and explorer in Antarctica, has been recognized with the naming of the Rutford Ice Stream and Mt. Rutford, both in Antarctica, in his honor. Additionally, Rutford Avenue on the U. T. Dallas campus bears his name in recognition of his accomplishments in developing U. T. Dallas as an outstanding center of excellence in teaching, research, and service to the Metroplex and to the State of Texas.

2. <u>U. T. System Board of Regents: Request for authorization to negotiate and enter into an Auditing Services Contract to perform audits of the funds managed by The University of Texas Investment Management Company (UTIMCO) for the Fiscal Year ending August 31, 2007</u>

RECOMMENDATION

The Chairman of the Audit, Compliance, and Management Review Committee recommends that the U. T. System Board of Regents authorize U. T. System staff to negotiate and enter into an auditing services contract with an independent auditor to be recommended at the meeting to (1) perform audits of the financial statements, (2) audit and report on management's assessment of the internal controls over financial reporting, and (3) audit the performance statistics for the fiscal year ending August 31, 2007, for the funds managed by The University of Texas Investment Management Company (UTIMCO) as listed on the next page.

- Permanent University Fund (PUF)
- The University of Texas System General Endowment Fund (GEF)
- Permanent Health Fund (PHF)
- The University of Texas System Long Term Fund (LTF)
- The University of Texas System Intermediate Term Fund (ITF)

The contract will provide for the option to renew for four additional one-year terms.

BACKGROUND INFORMATION

Fiduciary responsibility for the PUF, GEF, PHF, LTF, and ITF (the Funds) rests with the U. T. System Board of Regents. *Texas Education Code* Section 66.08 (f) requires that the U. T. System provide for an annual financial audit of the PUF, if the PUF is within the scope of funds managed by an external management corporation.

The Funds were audited by Deloitte & Touche, LLP, on an annual basis from UTIMCO's inception in 1996 through Fiscal Year 2002. On July 7, 2003, the Board of Regents authorized U. T. System staff to negotiate and enter into an auditing services contract with Ernst & Young, LLP, for one year with a right to renew in one-year increments for four years. The contract was renewed by the Board of Regents on February 4, 2004, February 10, 2005, February 9, 2006, and February 8, 2007.

Ernst & Young, LLP, notified UTIMCO on April 13, 2007, that the firm had declined to perform the audit of the investment funds managed by UTIMCO for the year ending August 31, 2007. The funds managed include the PUF, GEF, LTF, PHF, and ITF. Ernst & Young, LLP stated the reason for its decision was not unique to UTIMCO. The firm stated that, due to its interpretation of recent industry auditing changes, it was not possible to conduct a cost-effective audit approach for endowments similar to UTIMCO's that hold significant alternative investments with different year ends from the endowment year end. The firm noted the inherent delay between the reporting of valuations for certain alternative investments, which are audited at calendar year end, and the August 31, 2007, effective date of the investment funds' audit, could create associated risks. Accordingly, U. T. System issued a Request for Qualifications (RFQ) to select new outside auditors for the Funds managed by UTIMCO.

The process used for selecting the audit firm to perform the fiscal year ending August 31, 2007, audit of the Funds included an RFQ stating the objectives, timeline, and scope of work to be completed by the selected firm. The RFQ was issued by U. T. System to prospective bidders on May 9, 2007.

Written proposals were received on June 4, 2007 from two firms - Deloitte & Touche, LLP, and Weaver and Tidwell, LLP. Oral presentations and firm interviews were held on June 18, 2007.

3. U. T. Austin: Authorization to exercise an option to purchase approximately 2.436 acres of land located at 2200 East Sixth Street, Austin, Travis County, Texas, from Mr. Perry Lorenz, for a purchase price of \$1.5 million for the campus of The University of Texas Elementary School and authorization to transfer a total of \$1.945 million from Available University Funds (AUF) to include funding for other items related to the Elementary School

RECOMMENDATION

The Chancellor concurs in the recommendation of the Executive Vice Chancellor for Academic Affairs, the Executive Vice Chancellor for Business Affairs, and President Powers that authorization be granted by the U. T. System Board of Regents, on behalf of U. T. Austin, to

- a. exercise an option to purchase approximately 2.436 acres of land located at 2200 East Sixth Street, Austin, Travis County, Texas, from Mr. Perry Lorenz for a purchase price of \$1.5 million, plus closing costs and other costs and expenses to complete the acquisition of the property as deemed necessary or advisable by the Executive Director of Real Estate for the campus of The University of Texas Elementary School;
- authorize the Executive Director of Real Estate to execute all documents, instruments, and other agreements, subject to approval of all such documents as to legal form by the Office of General Counsel, and to take all further actions deemed necessary or advisable to carry out the purpose and intent of the foregoing recommendation; and
- c. appropriate an additional \$1.5 million in Available University Fund (AUF) reserves to U. T. Austin to fund the purchase.

It is further recommended that the Chancellor be authorized to approve a transfer of funds totaling \$1.945 million in Available University Fund (AUF) reserves to fund the land purchase and to fund the following items related to The University of Texas Elementary School:

- 1. Transfer to U. T. Austin of \$350,000 to cover the purchase price, land cleanup, and soil testing for adjacent property purchased from Capital Metropolitan Transportation Authority in 2007;
- 2. Transfer to U. T. Austin of \$70,000 to reimburse the cost of the classroom project built in 2004; and
- 3. Transfer to U. T. Austin of \$25,000 for use in funding The University of Texas Elementary School's gymnasium project.

BACKGROUND INFORMATION

U. T. Austin desires to exercise its purchase option to acquire the subject property, which is the campus of The University of Texas Elementary School located at 2200 East Sixth Street. On November 15, 2002, the State Board of Education granted a charter to The University of Texas Elementary Charter School at Austin. The U. T. System Board of Regents authorized the establishment of the elementary school on December 20, 2002. U. T. Austin opened the school in August 2003, which it operates under the name "The University of Texas Elementary School."

Also at its meeting on December 20, 2002, the Board of Regents authorized the lease or acquisition of the subject property. An Option/Real Estate Contract was entered into in January 2003, which granted the Board of Regents an option to purchase the property and enabled U. T. Austin to place modular buildings on the site in order to open the school in August 2003. The option contract provides for annual option fee payments and allows the Board of Regents to purchase the property between January 1, 2006 and December 31, 2007, at its then fair market value. Mr. Lorenz recently offered to accept a payment of \$1.5 million, approximately \$1 million less than the property's current fair market value, to enable U. T. Austin to complete the purchase.

The subject property is adjacent to a tract containing approximately 21,000 square feet located at 2201 Hidalgo Street. In accordance with the approval from the Board of Regents on August 10, 2006, that tract was purchased from Capital Metropolitan Transportation Authority for \$313,236.80 on April 27, 2007. It will be used in conjunction with the subject property for the campus of The University of Texas Elementary School. Additional modular facilities were installed on the site in 2004 and a permanent facility for the school was added to the FY 2004-2009 Capital Improvement Program in February 2005.

To fund the purchase of the 2.436-acre tract, U. T. Austin will use AUF reserves. The terms and conditions of the purchase are reflected in the transaction summary below.

In addition, the recommendation seeks formal authorization to transfer additional funds in the amount of \$445,000 to assist with recent Elementary School projects. Although Board approval is not required for any individual transfer, this approval is being sought because of the total funding involved.

4. <u>U. T. Pan American: Request for approval of authorization and changes related to a sports recreation and wellness facility fee; incidental and other fees; and course-related incidental fees effective Fall 2007</u>

RECOMMENDATION

The Chancellor concurs in the recommendation of the Executive Vice Chancellor for Academic Affairs, the Vice Chancellor and General Counsel, and President Cárdenas that the following authorizations and changes related to special, incidental, and course fees at U. T. Pan American for Fall 2007 be approved:

- a Sports Recreation and Wellness Facility Fee of \$75 per student per semester for the sports recreation and wellness facility scheduled to open in August 2007;
- b. charge of the Alternative Certification Program (ACP)/Alternative Certification Program Extension Fee either directly to the students participating in the ACP or to the school district employing ACP students, at the discretion of the ACP director;
- c. a Graduate Program Fee of \$75 per semester for students in the graduate Clinical Psychology or Experimental Psychology programs;
- d. Course-Related Fees ranging from \$5 to \$40, as attached on Pages 9 13; and
- e. rename the approved Computer Access Fee as the Information Technology Access Fee.

BACKGROUND INFORMATION

The new special fee for the sports, recreation and wellness facility was approved by students in a referendum held March 29 - April 1, 2004, authorized by the 79th Texas Legislature in 2005, and codified in Section 54.5421 of the *Texas Education Code*.

U. T. Pan American currently bills the ACP fees to the school districts that employ ACP students and the school district then collects the charges from the students via a payroll deduction. U. T. Pan American requests approval to have the option to charge the fee directly to students interning at school districts that do not or cannot recoup program costs. The fee is used to defray the cost of administering the ACP, including on-site internship supervision, evaluation and travel costs, seminars and mentoring. This fee is consistent with applicable statutory requirements under Sections 54.504 and 55.16 of the *Texas Education Code*.

The proposed new Graduate Program Fee would be used to defray the cost associated with the maintenance of administering standard practices, professional level psychological tests, and the associated scoring and interpretative software, as well as to purchase instructional materials. This fee is consistent with applicable statutory requirements under Sections 54.504 and 55.16 of the *Texas Education Code*.

Proposed new course-related fees would be used to defray specific costs associated with offering various courses in communications and the arts. These fees are consistent with applicable statutory requirements for incidental fees under Section 54.504 of the *Texas Education Code*.

The current Computer Access Fee is used to defray administrative costs incurred in providing access to and supervision of computer labs. Changing the name to the Information Technology Access Fee and the fee description will allow the fee to defray costs incurred in students' use of information technology including the provision of access and supervision of computer labs, supplying network access and infrastructure, servers and other information technology-related hardware, software, and services. This fee is consistent with applicable statutory requirements under Sections 54.504 and 55.16 of the *Texas Education Code*.

5. <u>U. T. Permian Basin: Request for approval of laboratory and course-related incidental fees effective Fall 2007</u>

6. <u>U. T. San Antonio: Discussion and appropriate action regarding proposed</u> revisions to Mission Statement

RECOMMENDATION

The Chancellor concurs with the recommendation of the Executive Vice Chancellor for Academic Affairs and President Romo that proposed changes to the U. T. San Antonio Mission Statement as set forth below be approved by the U. T. System Board of Regents and forwarded to the Texas Higher Education Coordinating Board for approval.

Proposed Revised Mission Statement

The University of Texas at San Antonio is dedicated to the advancement of knowledge through research and discovery, teaching and learning, community engagement and public service. As an institution of access and excellence, UTSA embraces multicultural traditions, serving as a center for intellectual and creative resources as well as a catalyst for socioeconomic development for Texas, the nation and the world.

Current Mission Statement

The University of Texas at San Antonio is the premier public institution of higher education in South Texas, with a growing national and international reputation. Renowned as an institution of access and excellence at both the undergraduate and graduate levels, UTSA is committed to research and discovery, teaching and learning, and public service. UTSA embraces the multicultural traditions of South Texas, serves as a center for intellectual and creative resources, and is a catalyst for the economic development of Texas.

BACKGROUND INFORMATION

In Spring 2006, U. T. San Antonio began a year-long strategic planning process, labeled UTSA 2016. This process involved a core group of 80 faculty, staff, students, administrators, and community members; nine thematic planning groups from across U. T. San Antonio that reported to the core planning group; and the Silver to Gold Commission, selected members of U. T. San Antonio's external community. These groups met regularly throughout the year to develop the plan. Additionally, over 20 meetings were held with constituent groups across the University community throughout the process to facilitate dialogue and gather input.

Part of this strategic planning process involved developing vision and core values statements and revising U. T. San Antonio's mission statement. As dialogue took place about the kind of institution U. T. San Antonio is now and hopes to become, participants were passionate about the fact that both research and access should continue to be emphasized in the mission statement. Participants also agreed that although U. T. San

Antonio continues to see itself as an important part of the social and economic fabric of San Antonio and South Texas, its mission must be within the context of globalization if U. T. San Antonio and the region are to be successful. Thus, the decision was made to broaden the mission statement to include a national and global emphasis.

The proposed revised mission statement was endorsed unanimously by the University's strategic planning groups, which included representation from the Faculty Senate, Staff Council, Deans' Council, Student Government Association, and Development Board as well as the U. T. San Antonio executive committee.

7. <u>U. T. Austin: Recommendation regarding an honorific naming of the College of Engineering and change of reference from College to School</u>

RECOMMENDATION

President Powers and Dean Ben Streetman will make a recommendation concerning an honorific naming for the College of Engineering and retitling of the College as a School.

If the recommendation is approved, the General Counsel to the Board will update the Regents' *Rules and Regulations*, Series 40601, concerning entities comprising the U. T. System institutions.

8. <u>U. T. System: Briefing on proposal to revise Accountability and</u> Performance framework and reporting schedule

Dr. Geri H. Malandra, Vice Chancellor for Strategic Management, will brief the Board on proposed changes to the U. T. System Accountability and Performance framework and reporting schedule attached on Pages 20 - 26.

Revised UT System Accountability and Reporting Framework

Overview

The UT System has published a comprehensive, annual accountability and performance report for the past four years. The use of these reports at the system and campus level, together with the publication in August 2006 of a new ten-year strategic plan for the UT System, and the presence of more robust accountability data sets at the System and at the Texas Higher Education Coordinating Board (THECB), will make it possible for the UT System to focus and streamline its future accountability and performance reports.

A revised accountability framework for the UT System would provide a focus on:

- 1. Outcomes, analysis, and metrics that match System priorities in its new strategic plan.
- 2. "At-a-glance" views of trends for key metrics.
- 3. Progress tracking and in-depth analysis of key initiatives and correlations among indicators, on graduation rates, cost of education, learning outcomes, health care, and other critical topics.
- 4. Institution-specific profiles with in-depth analysis of trends in comparison with peer institutions.

This framework assumes a reliance on a robust, unit-record set of data in a statistical source book that would be used to create the higher level analyses and correlations in the accountability report, together with robust data sets collected by the THECB. It also assumes a distinction between accountability and strategic management of all initiatives, with an annual cycle of in-depth reports to the Board on special topics, and annual updates on progress toward overall strategic plan goals (schedule attached on pp. 3-6).

Proposed framework

- I. <u>System trends</u>. Would provide data on core, strategically key indicators, with "at-a-glance" System-level tables and graphs.
- II. <u>Strategic initiatives</u>. Would present discussion of progress on System-level initiatives and priorities such as the competitiveness initiative, productivity and efficiency initiatives such as shared services, and financial and information security planning.
 - For academic institution priorities, progress would be summarized on: enrollment management; community college partnerships; admissions standards; tuition-setting, cost, and financial aid; graduation rates; STEM degree production; and learning outcomes.
 - For health institutions, progress would be summarized on improving health care, medical innovations, diversity, and professional and high-priority degrees.

III. Institution profiles.

- "Snapshot," including the short mission statement and top five priorities from the Compact and a statistical profile.
- Analysis section focusing on analysis of data trends from a 360-degree, cross-tabbed perspective versus a metric-by-metric approach. Focus would be on more extensive analysis and context, for example, how tuition-setting, graduation rates initiatives, enrollment management plans, etc., all work together at each institution.
- Tables and graphs on campus-relevant metrics and trends.
- Overall peer comparisons (based on campuses' current peer lists) will be included, as well as other national trends or examples.

- May 2008: New Accountability and Performance Report
- May December 2007: Separate, in-depth reports on special topics
