## MEETING NO. 1,039

THURSDAY, NOVEMBER 6, 2008.--The members of the Board of Regents of The University of Texas System convened this special called meeting via telephone conference call at 7:49 a.m. on Thursday, November 6, 2008, in the Chairman's Office, Ninth Floor, Ashbel Smith Hall, 201 West Seventh Street, Austin, Texas, with the following participation:
