

FIRST AMENDMENT TO MASTER CLINICAL STUDY AGREEMENT

**Between
WYETH PHARMACEUTICALS INC.,
and
THE UNIVERSITY OF TEXAS SYSTEM**

This First Amendment to the Master Clinical Study Agreement ("Amendment") dated October 3, 2008, and made effective as of July 22, 2008 ("Effective Date") is made among Wyeth Pharmaceuticals Inc., acting through its division, Wyeth Research (hereinafter referred to as "Company") and each of The University of Texas Health Science Center at San Antonio, The University of Texas Health Science Center at Houston, The University of Texas MD Anderson Cancer Center, The University of Texas Health Science Center at Tyler, The University of Texas Medical Branch at Galveston, and The University of Texas Southwestern Medical Center at Dallas (each an "Institution" and, collectively, the "Institutions"), and each a member institution of The University of Texas System, as governed by its Board of Regents..

WHEREAS, Company and Institutions wish to amend the Master Clinical Study Agreement (the "Agreement") to extend the termination date of the Agreement for an additional 12 months.

NOW, THEREFORE, Company and Institutions for valuable consideration and intending to be legally bound, agree as follows:

1. The first sentence of Section 13.1 (Termination of Master Agreement) of the Agreement is hereby deleted in its entirety and shall be replaced with the following:

"The term of this Master Agreement shall begin upon the Effective Date and shall continue for the longer of six (6) years from the Effective Date or until the obligations under all Protocol Agreements are fully performed, unless sooner terminated in accordance with this Article 13."

2. All other terms of the Agreement, as amended, shall remain the same and in full force and effect.


3. This Amendment may be executed in one or more counterparts and the counterparts, together, shall constitute a single agreement.
