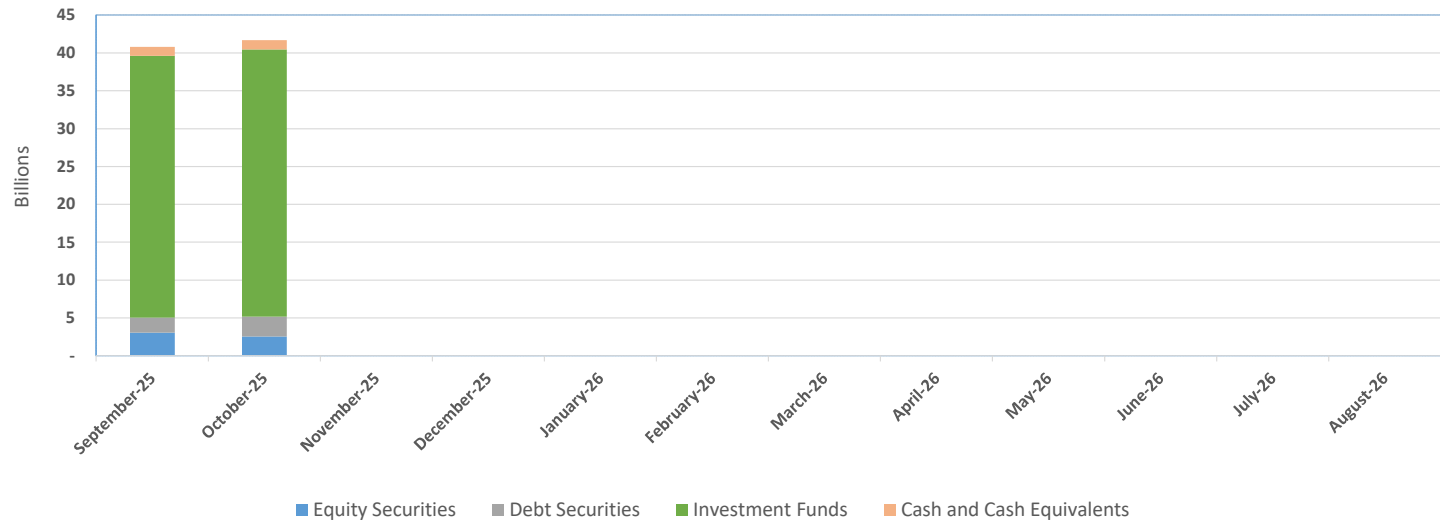
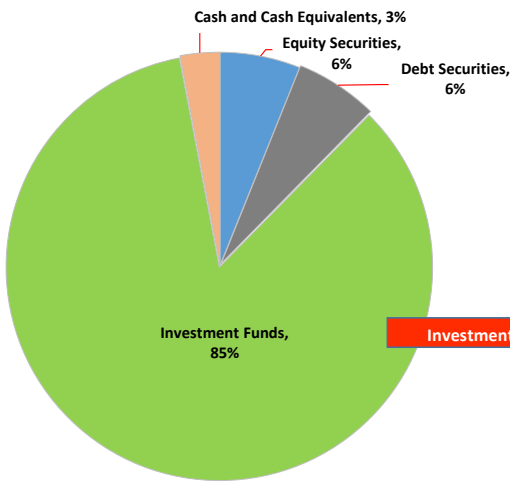

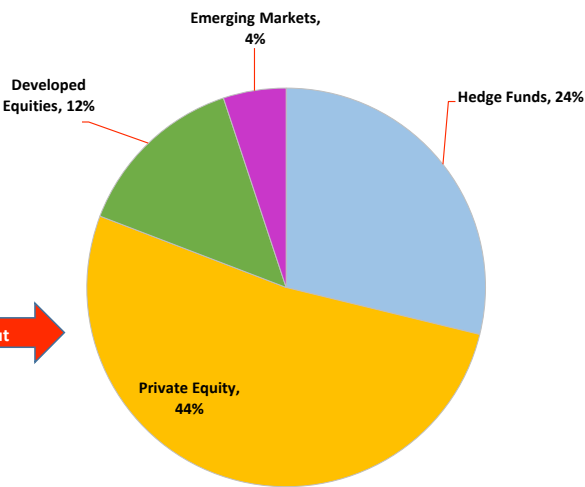
Investment Portfolio - FY 2026



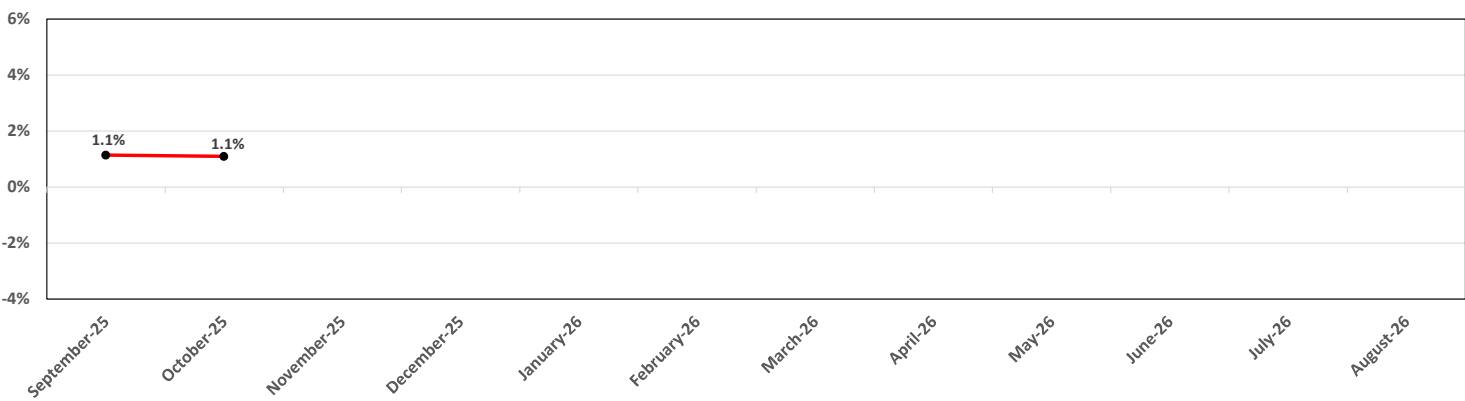
Investment Portfolio as of October 2025
