At a regular meeting of the Board of Regents held this day. Regents Henderson, Braxton, Gregory and Spencer were present.

On motion of Regent Spencer, the matter of office room for Mr. Sawyer, the Lab. Dept., and of more quiet quarters desired by Mr. Wins, the Book Keeper, was referred to the Committee on Buildings and grounds.

The Board requested Prof. Simkins to draft two bills to be presented to the legislature now in session:

- I - To protect and secure to the University the minerals on its lands.
- II - To provide for a mineral survey of Texas by the School of Geology under the auspices of this University.

A communication was received from J. A. Elkins, Business Manager of the Cactus for 1900-1901, asking the Board to subscribe for 100 copies of the said Cactus at \$1.50 per copy.

The resolution passed by the faculty on the 14th inst recommending that, beginning with the Commencement of 1906, only one degree, to wit, Bachelor of Arts, be conferred upon students completing the work required for graduation in the department of Literature, Science and Arts, was laid over to be considered at a subsequent full meeting of the Board, before the Board.

Regent Gregory was requested to make a date with Governor Sayre for consultation about University business before the 27th legislature.

Adjourned to tomorrow morning the 16th inst.

Jan. 16, 1901. The Board met pursuant to adjournment, regents Henderson, Bryan, Gregory and Spencer being present.

On motion of Regent Gregory President O'neather was instructed to arrange a time for the regents to appear before the finance committees of the Senate and the House, and for the Committee on Education to visit the University; and that all members of the Board of Regents be urged to attend a meeting to be called by the chairman for the purpose of meeting the committee above referred to.

It was ordered that the Secretary of the Board shall call a meeting of the Board at such time as may be appointed by the President.

The anatomical bill prepared by Prof. Keller, of Medical Department, was presented to and approved by the Board, and ordered to be urged for passage by the 27th legislature at its present session.

The bill, drawn by Prof. Simkins, to secure to the University the ownership and use of all minerals found on its lands, was presented to and approved by the Board, with the view of having it passed by the legislature during its present session.

The President read to the Board the bill prepared by Prof. Simkins providing for a survey of the mineral lands of the University was referred to the Committee on Legislation consisting of Regents Marsh, Gannoad and Bryan.

The resignation of Dr. G. P. Hall, Prof. of Ophth. Otolaryngology, in the Medical Department, was accepted and the President was instructed to notify

Dr. Hall of such acceptance, and to express to him the thanks of the Board for the satisfactory manner in which he has performed the duties of his professorship as well as their cordial wishes for his prosperity and happiness

The following ~~action~~ resolution by the faculty of the Medical Department was approved and adopted by the Board:

"Resolved that the Faculty of Medicine recommend to the Board of Regents that, in accepting the resignation of Dr. P. Hall for the chair of Ophthalmology, etc. they declare this position to be a lectureship as before Dr. Hall's elevation to the full professorship; and that it be filled as formerly, each year from nominations made before the faculty by the professor of Surgery and recommended by vote of the faculty to the Board of Regents."

On motion made and carried Dr. John B. Haden was elected lecturer in the Medical Department on or Ophthalmology, Otolaryngology and Laryngology, without salary.

It was ordered that the salary of Professor J. F. M. Paine be raised to three thousand dollars per annum to begin Sep. 1, 1901.

It was ordered that, beginning Sep. 1, 1901, the salary of Dr. Henry P. Locke, as Dean of the Medical Faculty, shall be one thousand dollars per annum.

The sum of \$191,50 was appropriated to pay the Bill of Bryan Hard-ware company dated Feb. 14, 1900.

The petition of A. Caswell Ellis, Adjunct Prof. of Pedagogy, for leave of absence from Oct. 1, 1901 to Jan. 1, 1902, without salary during such absence - was granted, with the understanding that his work during such absence shall, without cost to the University, be performed by other professors in the University.

The petition of Gymnasium Director Curtis for an appropriation to purchase mats for the Allen's gymnasium was not granted, owing to lack of funds.

The request of Prof. Taylor for an additional appropriation of \$30.00 to the Dept of Engineering was not granted.

It was ordered that, the matriculation fee paid by R. M. Berrenat, ^{for 1899-1900} he returned to him, the same having been paid by mistake, as he was entitled to a scholarship at first scholar in his class in the Deaf and Dumb Institute, an affiliated school.

The petition of J. L. Dalton asking that \$20.00 of the \$30.00 paid by him for matriculation into the Law Department be returned to him on the ground that, after a few lectures in said Department, he was, on his own request, transferred to the Academic Department, was refused. ~~the~~

The petition of Mr. Ramsdell that the \$10.00 matriculation fee paid by him for session of 1900-1901 be returned on the ground that he was awarded the Alumni scholarship for the best entrance examination in said session and because it had been published in a circular sent out by the Registrar that the entrance fee would be remitted in favor of such scholarship, - was refused, it not appearing that the Board of Regents had authorized such remission.

A bill of the Eugene von Boeckmann Publishing Company was exhibited to the Board accompanied by a note from Mr. C. B. Winn, University book-keeper. Said bill is for \$817.76, and dates from Sep. 29, 1898 to Nov. 1, 1900, a period of 2 yrs, 1 mo. - Mr. Winn and the Proctor both stated that they had repeatedly urged the von Boeckmann Company to send in their bill. The Proctor stated that he had warned them again and again that

 ulty of the University of Texas was laid before the Board of Regents of
 said University:

"Resolved, That the Department of Engineering in the
 University of Texas be hereby established for the purpose of giving
 special courses of instruction in civil, sanitary, electrical and mining
 engineering; and the following professors, instructors and assistants
 are hereby assigned as the faculty of that department; provided that the
 faculty of the engineering department do not act as a distinct body, but
 act always with the faculty of the academic department:--

- A. L. McRae, Physics and Electrical Engineering.
- H. W. Harper, General and Industrial Chemistry.
- W. W. Norman, Biology.
- G. B. Halsted, Mathematics.
- F. W. Simonds, Geology and Mineralogy.
- Leslie Waggener, English.
- Sylvester Primer, Modern Languages.
- Arthur Lefevre, Instructor in Mathematics.

And, Whereas on January 17, 1895, the Board of Regents created the de-
 partment of engineering for the above purposes. (minutes of the Board of
 Regents, p. 25) and

Whereas the faculty, in accordance with the above res-
 olution, appointed, at a meeting held January 22, 1895, the following pro-
 fessors a committee to prepare the matter for the catalogue of 1894--95,
 viz. Professors Taylor, Simonds, McRae, Harper, Norman, (minutes of the
 Faculty, p. 362); And

Whereas, said committee prepared the following course
 of study in mining engineering which became effective in the Fall of 1895:
 Mining Engineering.

"The courses comprising the group of studies leading to the degree of
 Engineer of Mines are indicated in the tabulated statement following.
 The distinctive features of the group are the prominence given (1) to
 Underground surveying, the practice of U.S. Deputy Mineral Surveyors, etc.,
 in connection with civil engineering; (2) to chemistry, qualitative and
 quantitative analysis, and metallurgy; (3), to Geology, both general
 and economic; (4), to mineralogy, physical and descriptive, and blow-pipe
 analysis, and (5) to ore deposits and mining.

"The character and the scope of the work in Geology, mineralogy, and
 ore deposits, may be seen by reference to courses 1, 4, 5, and 6, of the
 School of Geology, Department of Literature, Science and Arts. The spec-
 ial course in mining covers a consideration of the following subjects:
 Exploration and methods of mining, sinking of shafts, timbering, boring,
 tunneling, drilling, blasting, ventilation, pumping, transportation, etc.

On account of the growing importance of electricity in mining, a full
 course in electric engineering is required of all candidates offering
 themselves for a degree". (vide catalogue of the University of Texas,
 1894--1895, pp. 126, 127, also p. 128.)"

Therefore, Be it resolved that, in order to meet the increased
 interest and activity in the mineral development of the State, said course
 in Mining Engineering be and is hereby expanded into a school of mines.

Resolved that the following course of study designed for the prepara-
 tion of mining engineers who shall be competent to conduct mining and
 metallurgical operations "from the prospecting for the mine through its
 working, and from the treatment of its ores to the delivery of its fin-
 ished product on the market", be adopted.

Course of study prescribed for the degree of Engineer of Mines.
 Requirements for admission. The requirements for admission to the
 School of Mines shall be as follows:-- In English, History and Mathemat-
 ics, the same as for the Department of Literature, Science, and Arts. In
 addition to these studies, German A and B, and (a) Physiology and Hygiene
 or Physiography, and (b) Chemistry and Physics, (one high school unit in
 each or two high school units in either one.) Candidates who cannot sat-
 isfy the requirements in German and Science may take these subjects in
 the University, but they cannot be counted towards a degree.

It was ordered that the sum of \$72.00 be appropriated to the School of Zoology, it being the amt derived from the sale of four old microscopes belonging to said school.

Regent Frank M. Spencer, Chairman of Medical Committee, presented a written statement of the expenditure of the sum of \$9,816.66 for emergency repairs and supplies for the Medical Branch of the University of Texas, made necessary by the storm of Sep. 8, 1900; and showing that said sum had been paid by Regent Geo. W. Brackenridge, by reason whereof this University is indebted to Regent Brackenridge in said sum of \$9,816.66. Said statement by Regent Spencer further set forth that bills to the amount of \$2,125.56 are due and unpaid "for work and supplies made necessary by the storm of Sep. 8, 1900, and including supplies necessary supplies for the school."

Regents Henderson, Bryan, Spencer, Marsh, were present. Land Agent R. E. L. Sauer having petitioned the Board for a room in the University building and the matter having been referred to the Committee on Buildings and Grounds, Regent Spencer, on behalf of said committee, reported that they had assigned to Mr Sauer the front portion of the room (No 45) occupied by the Dean. Report received and adopted.

The use of the auditorium for a series of lectures on art by Mrs Sherwood was granted upon such conditions as President Prather may deem proper.

On the petition of Prof. Sutton, the name of the "School of Pedagogy" was changed to "The School of the Science and Art of Education", with corresponding change of the title of professors and instructors in said school.

At the request of Land agent R. E. L. Sauer and on motion of Regent Marsh, the sum of \$110.00, or so much thereof as may be necessary, was appropriated to furnish the Land Agents' office with a type-writer, desk, chairs, and letter files.

Field and Economic Geology to make a mineral survey of the public lands of Texas in accordance with the law providing therefor passed by the 27th Legislature, said survey to be made under the direction of the President of this University. The salary of Prof. Phillips was fixed by the Board at \$2,500 per annum, to begin May 4, 1901.

L. M. Layton's Insurance

Report Gregory presented a communication from L. M. Layton, Austin agent of the Helvetia Swiss Fire Insurance Company asking that the rate for that company be raised from 1 1/2 per cent to 2 1/2 per cent for 5 yrs. the same that was paid other companies changing insurance for the University, and offering to give off as a rebate 2/3 of his commission which would be five percent of the additional premium to be collected ~~to be collected~~, namely, in fact, the rate of 2 1/4 per cent for five yrs on the \$20,000 carried by the Helvetia; and of \$150.00 additional premium to be paid said company.

On motion of Report Brackbridge it was ordered that the proposition of Mr Layton (vide correspondence file) be accepted and that a new policy for the \$20,000 be substituted for the one now in possession of the University.

The sum of \$114.00 was appropriated ~~to~~ to pay the bill of Jeff. Banton for hauling Geological collection from the State Capitol to the University, to be paid out of the \$10,000 appropriation for mineral survey made by the 27th Legislature at its last session.

\$126.90 to reimburse Dr Phillips moving minerals from the hospital

The sum of \$126.90 was appropriated to reimburse Prof. Wm B. Phillips cash paid out by him for the University in removing Geological collection from State Capitol to the University, - the same to be charges to the \$10,000 appropriated by the 27th Legislature for mineral survey.

Geo. B. Stowe's plans adopted for the buildings

On motion of report Brackbridge, it was ordered that the plans of ~~erected~~ ^{erected} Geo. B. Stowe, for remodeling and restoring the buildings of the Medical Department, be adopted with such modifications as may be necessary to bring the cost within \$30,000 and

May 7, 1901

That the Governor be requested to appoint the stone architect for said work. Also that bids for construction be advertised for, once a week for one month in the Galveston and Dallas News, The Houston Post and San Antonio Express. It was further ordered that a bid be selected by the Medical Committee and submitted to the Board for approval.

On motion made and carried, it was ordered that the resolution fixing the close of the current session of the Medical Department on the 30th of June be so changed that it shall close June 15, next.

On recommendation of the Building Committee it was ordered that the sum of \$250.00 be paid Charles Sherr on his claim of \$500.00 as balance in contract for addition to University Hall, and that the remaining \$250.00 be paid to him when he shall have completed certain repairs to the satisfaction of the Proctor.

At the request of President Thayer the sum of \$50.00 was appropriated ~~for expenses incurred in the reception of President McKinley at the University on the 31st instant.~~ ^{for expenses incurred in the reception of President McKinley at the University on the 31st instant.}

The sum of \$50.00 was appropriated for the purchase of a United States flag for the University.

The Board ratified the action of the President in transferring to the mineral survey the 5 horse power motor belonging to the School of Physics for \$200.00, this sum to be transferred to the School of Physics; and appropriated \$85 which, together with said \$200.00, is to be used in paying for the 12 horse-power motor purchased by the School of Physics, as per order of the President.

The sum of \$280.00 was appropriated to buy a tenoning machine, including freight, piecing, belting, cartage &c, for the School of Physics.

One hundred dollars was appropriated for lumber & supplies for the School of Physics until June 15, 1901.

May 4, 1901

On motion of Regent Brackenbury, Miss Berta Lander was appointed tutor in Latin in this University for the session 1901-1902, at a salary of six hundred dollars per annum. The sum of \$534.00 was appropriated to meet deficit on ~~the~~ appropriation for coal for session 1900-1901.

The sum of one hundred and twenty five dollars was appropriated ~~to~~ and erected a pair of scales for rough coal.

The president was granted leave of absence during vacation for such time as may suit his convenience.

Mineral Survey.

The following resolutions, drawn by President Proctor under direction of the Board, were adopted:-

For the purpose of organizing and putting into effect the Mineral Survey of the lands belonging to the public schools, University and Asylums and of the State, authorized by an Act of the Legislature approved March 26th, 1901, in accordance with the terms of said act, it is hereby provided:

First, that Dr. Wm. B. Phillips be and is hereby promoted from Instructor in Economic and Field Geology to be hereafter Professor in Economic and Field Geology and Mineralogy in the University of Texas, and as such Professor shall have, under the direction of the President of the University, and subject to such instruction as may be given him from time to time by the Board of Regents through the President of the University, special charge of said mineral survey, and of the Geological Collection removed from the Capitol to the University, and of such additions as may be made thereto during the progress of such survey, and also of the conduct of said survey in the field and of all assays and analyses made by authority of the terms of the law providing for said survey.

Second, that said Wm. B. Phillips be paid a salary of \$2800 per annum from this date, of which \$1,000 shall be paid from the appropriation hereinafter made out of the funds of said Mineral Survey and the remaining \$1,800 out of the general revenues of the University as heretofore.

Third, that said Wm. B. Phillips in connection with his work in the field shall also give instruction in the University in practical economic and field geology and mineralogy as contemplated by said law.

Fourth, that said Phillips shall be charged with the collection and distribution of statistics relating to the mineral production of the State under the direction of the President of the University.

Fifth, that all assays and analyses made by authority of said law shall be made in the Chemical Laboratory of the University in the order directed by said Phillips and under the supervision of Dr. H. W. Harper, Associate Professor of Chemistry, and shall be signed and certified by said Harper as Chemist for said mineral survey.

Sixth, that Benj. F. Hill is hereby elected as Assistant Geologist and Mineralogist in practical economic and field geology to assist the said Phillips in the field in making said survey and his salary is fixed at the rate of \$1800 per annum beginning from this date.

Seventh, that O. H. Palm and G. H. Forrell are hereby elected assistant Chemists at salaries at the rate of \$1000 and \$800 respectively to begin on such dates as shall be designated by the President, and said assistant Chemists shall be employed in making analyses and assays for said mineral survey subject to the direction of said Phillips and under the supervision of said Harper who shall sign and certify to such analyses and assays as above provided, and in addition thereto, in case there shall be found time, shall do such work in connection with ^{The Chemical Laboratory and} arranging, labelling and cataloguing the geological and mineral collection at the University as may be determined by said Phillips under the direction of the President.

Eighth, that the expenses of the removal and rearrangement of the Geological Collection from the Capitol to the University and the repair of cases, instruments and equipment, subject to the approval of the President, shall be paid out of the funds appropriated by the Legislature for said survey.

Ninth, That the following list of fees and charges upon the terms stated shall be charged and collected and paid into the hands of the Proctor of the University for making assays and analyses, and the same shall be kept in a separate account as receipts from said survey, to wit:

Qualitative Tests.

For identifying substances, without determining the amount of any constituent present, the charge will be one half of the cost of a quantitative determination of the substance. In the case of the precious metals, however, the charge will be the same as for a quantitative assay.

Water: Waters are analyzed with a view to determine their fitness for

1. Domestic use (potability, and suitability for laundry use)
2. Boiler use (whether injurious to boilers when used for the production of steam).
3. Manufacturing purposes (suitability in specific manufacturing processes).
4. Mineral waters (medicinal value).

For analyses embraced in the foregoing categories the following charges are made: 1 and 2, each analysis, \$20 to \$50, depending upon the number of constituents determined - average charges, \$25 to \$35. 3. Each analysis, \$20 to \$100; rarely beyond \$50 - average charges, \$25 to \$40. 4. Each analysis, \$40 to \$200, average charges \$50 to \$75.

The quantity of water needed for each analysis will depend upon the type of analysis and completeness of same. For 1 and 2, two gallons are sufficient, more is sometimes required; for 3, two to four gallons; and 4. at least five gallons.

 Gentlemen: The Board of Lady Managers of University Hall beg to offer, through the undersigned, the following report of the Board for the year past.

As is known, the Board of Lady Managers during the session of 1899-1900 transferred the management of the dining room to a club of students known as University Hall club, under suitable

about the University of Texas. The result was so satisfactory that the same arrangement was entered into for the past session.

7 front. House. However, owing to the damage done to the building by the storm of Sept 5, 1900, and the difficulty experienced in obtaining suitable lodging for the male students during the past session, it was determined to transfer the privilege of occupation of the rooms from the few women students to the men, the women being in the meanwhile provided with ~~rooms~~ accommodations through the generosity of the building of the University of Texas Chapter of the Alpha Xi Omega fraternity by the chapter. The management of the rooms of University Hall was given to a committee of the University Hall club, in whose charge the Board of Lady Managers wishes to state that the execution of the installation was carried out in a most satisfactory manner. The Board is well satisfied with the advantages which have been demonstrated during the past session by thus filling the Hall with the men students, that it would recommend that the same plan be continued at least for the present until the number of women students has sufficiently increased to make the restoration of the building to them at least a financial possibility. But a single woman student remains at the close of the session for whom provision in the future must be made, - although of course there may be more at the opening of the coming session. During the past session there were but three. The income from rooms from so few occupants will be utterly insufficient even to maintain the required service, to say nothing of the numberless other expenses connected with the lighting, heating, payment of water and items of repair constantly arising. While it would be unfair to impose further on the generosity of the Medical Fraternity by continuing to use its building, the Board of Lady Managers feel that it would be wise to make arrangements with the owner of some convenient and suitable lodging house to accommodate the few women students for the present and to continue to allow the full occupation of University Hall by the men, until the number of women students shall increase sufficiently to justify the original plan. It is, however, in the opinion of your members, a financial arrangement can be made covering the difficulty suggested, the Board of Lady Managers wishes to recall the above

recommendations and will gladly donate the University Hall again to women students only.

Appended are our monthly reports of the University Hall Club, covering the income and disbursements of the dining Hall for each month, as well as the report of the same organization of the income from rooms rented to the students, both arranged by Mr J. J. Terrell, the Treasurer of the University Hall Club for the past session. The financial report of the Treasurer of the Board of Lady Managers also accompanies this communication.

Article I. The Contractor under the direction and to the satisfaction of George B. Stame acting for the purposes of this contract as agents of the said Owner, shall and will provide all the materials and perform all the work mentioned in the specifications and shown on the drawings prepared by the said Architect for the repairs, reconstruction and alterations to the Medical College and University Hall located in the city and county of Galveston, State of Texas, which drawings and specifications are identified by the signatures of the parties hereto.

Article II. The architect shall furnish to the contractor such further drawings or explanations as may be necessary to

detail and illustrate the work to be done, and the contractor shall conform to the same as part of this contract so far as may be consistent with the original drawings and specifications referred to as identifies, as provided in Art. I.

It is mutually understood and agreed that all drawings and specifications are and remain the property of the architect.

Art. The contractor shall provide sufficient, safe and proper facilities at all times for the inspection of the work by the architect or owner or their authorized representatives. He shall, within twenty-four hours after receiving written notice from the architect to that effect, proceed to remove from the grounds or buildings all materials condemned by him, whether worked or unworked, and to take down all portions of the work which the architect or owner shall by written notice condemn as unneeded or improper, or as in any way failing to conform to the drawings and specifications.

Art. Should the contractor at any time refuse or neglect to supply a sufficiency of properly skilled workmen, or of materials of the proper quality, or fail in any respect to prosecute the work with promptness and diligence, or fail in the performance of any of the agreements herein contained, such refusal, neglect or failure being certified by the Owner or architect, the Owner shall be at liberty, after three (3) days' written notice to the contractor, to provide any such labor or materials, and to deduct the cost thereof from any money then due or thereafter to become due to the contractor under this contract; and if the Owner or architect shall certify that such refusal, neglect or failure is sufficient ground for such action, the Owner shall also be at liberty to terminate the employment of the contractor for said work and to enter upon the premises and take possession, for the purpose of completing the work comprehended under this contract, of all materials, tools and appliances thereon, and to employ any other person or persons to finish the work, and to provide the materials therefor; and in case of such discontinuance of the employment of the contractor he shall not be entitled to receive any further payment under this contract until the said work shall be wholly finished, at which time, if the unpaid balance of the amount to be paid under this contract shall exceed the expense incurred by the Owner in finishing the work, such excess shall be paid by the Owner to the contractor, but if such expense shall exceed such unpaid balance, the contractor shall pay the difference to the Owner. The expense incurred by the Owner as herein provided,

either for furnishing materials or for finishing the work, and any damage incurred through such default, shall be audited and certified by the architect, whose certificate thereof shall be conclusive upon the parties.

Art. The contractor shall complete the several portions, and the whole of the work comprehended in this agreement by and at the time or times hereinafter stated on or before the 1st day of October in the year 1901; and in default thereof the contractor shall pay to the Owner \$50.00 per day for every day thereafter that the said work shall remain unfinished, as and for liquidated damages. Should the contractor be obstructed or delayed in the prosecution or completion of his work by the act, neglect, delay or default of the Owner, or the architect, or of any other contractor employed by the Owner upon the work, or by any damage which may happen by fire, lightning, earthquake or cyclone, or by the abandonment of the work by the employees through no default of the contractor, then the time herein fixed for the completion of the work shall be extended for a period equivalent to the time lost by reason of any or all of the causes aforesaid; but no such allowance shall be made unless a claim therefor is presented in writing to the owner or architect within twenty-four hours of the occurrence of such delay.

Art. It is hereby mutually agreed between the parties hereto that the sum to be paid by the Owner to the contractor for said work and materials shall be \$18,988.00, eighteen thousand nine hundred and eighty eight dollars which price also includes plumbing, - and that such sum shall be paid in current funds by the Owner to the contractor in installments as follows:

75% of the value of the labor and material placed in the building payments to be made every three weeks. It is further mutually agreed between the parties hereto that no certificate given or payment made under this contract, except the final certificate or final payment, shall be conclusive evidence of the performance of this contract, either wholly or in part, and that no payment shall be construed to be an acceptance of defective work or improper materials.

Art. The contractor shall during the progress of the work maintain full insurance on said work, in his own name and in the name of the Owner, against loss or damage by fire. The policies shall cover all work incorporated in the building, and all materials for the same in or about the premises, and shall be made payable to the parties hereto, as their interest may appear; and in case of failure to do so the Owner may the said work insured and deduct the cost of said insurance from the contract price of said work.

To the Hon. Board of Regents of the University of Texas. Gentlemen: In pursuance of the plan outlined to your honorable body last year by Dr. Allen J. Smith for the Univ. of Texas Chapter Chapter of Alpha Nu Pi Omega Medical Fraternity, the Chapter begs to report through the undersigned committee that the property in the South East corner of Tenth Street and Strand, opposite the Medical College building was purchased from its owner, the Deering estate, and in due course of time was transferred to the University of Texas by the Chapter's representatives for such purposes as may best conduce to the good of the school in your opinion. The transfer was, for various reasons delayed and the property was legally in the hands of the Chapter at the time of the storm on Sep. 8, 1900, and especially, the difficulties besetting the school from the loss of the Nurses' Home and the serious damage done to the University Hall, the Chapter felt that it could best serve for the good of the institution by postponing the intended occupation of the property as a home for the members of the fraternity and offering it for the year as a home for the nurses and such women students as might attend the Medical Department. This offer was accepted and

The buildings have been and are now so employed, the Chapter in the meanwhile renting a hall in town for purposes of meeting and its members finding accommodation whenever it was possible in the different students' lodging-houses. The interest on the note given for purchase money became due on May 12, 1901, and was paid.

Realizing, however, that it was your expressed intention to utilize the buildings until such time as the University may require the ground for expansion, and with the earnest wish to demonstrate the advantage of concentrating our students in conveniently placed houses, and with the further wish to have the Chapter enabled by rental of the rooms of the building to its members to earn the obligation assumed in the purchase and presentation of the property to the University; the Chapter now requests of your honorable body that you take steps to accommodate the nurses and women students therein and definitely empower it to occupy the building for the purposes outlined.

In order to accomplish the ends in the most satisfactory manner, the Chapter suggests that the building be placed in the hands of a Board of Managers with organization and powers similar to that controlling University Hall, - namely, to appoint such a board, granting it power of self-renewal as may be required and of amendment of suitable rules for the conduct of the house, i.e. ^{requiring} annual reports of financial and restrictive matters, and ratifying the action of such Board as your agents, as far as possible.

It would be well, too, by definite action to permit the use of the income from the building for the payment of obligations incurred by the purchase of property and any necessary repairs ~~and~~ for the expenses of carrying on the house. The Chapter would suggest as the personnel of such a board, Dr. Edward Randall, Dr. Allen J. Smith, Dr. William Gamman, Mr. Davis H. Lawrence and Mr. Bismark Ferguson.

In order that the Building may be more readily named, the Chapter would suggest that the Board of Regents assign some suitable name to it - and insert for their suggestion the term, "Asclepias Hall", from the name of the Greek mythological Greek father of Medicine, Asclepius. Charges against Dr J. F. M. Paine

The following communication was presented to the Board at its meeting in Galveston, June 15, 1901.

"Galveston, Texas, April 9, 1901.
To the Hon. Board of Regents, University of Texas.
Gentlemen: I beg leave to present for your consideration the charges which follow against Dr J. F. M. Paine, professor of gynecology and obstetrics in the Medical Department of the University of Texas, and to request the Hon. Board of Regents to investigate the charges. I would state that for nearly six years I have been connected with the teaching of Gynecology in the Medical Department of the University, and thoroughly understand familiar with existing conditions; and am convinced that the teaching in this department is not what it might be.

- The principal defects are as follows:
- 1- Failure to properly utilize clinical material.
 - 2- Dismissing patients (in many difficult cases) from hospital without operations.
 - 3- Superior ability as an operator.
 - 4- Alterations and falsifications of hospital reports in catalogue.
 - 5- Disagreeable and overbearing deportment and conduct tending to promote ridicule.
 - 6- General inefficiency of teaching.

The foregoing statements can, I think, be substantiated by reliable and responsible individuals. Very respectfully, J. E. Kennedy."

The above communication was referred to the Medical Committee for investigation and report. The following report of said committee was submitted to the Board, and approved and unanimously adopted by them.
"Your Medical Committee to whom

referred the charges and specifications against professor J. F. M. Paine by Dr J. E. Your Medical College Committee, in the exercise of the plenary power granted to them by the Board of Regents, have gone carefully over the existing conditions with reference to the old wooden building, dilapidated by the storm, situated on the Sealy Hospital grounds and formerly used as a negro hospital ward; and a new building to be built for that purpose, of brick, by money donated by philanthropic persons for the specific purpose in the sum of \$18,000.00, beg leave to report that they have authorized Architect George B. Stowe to prepare drawings and specifications, and to advertise for bids for moving and repairing said building. The building is to be removed to the north-east corner of the grounds and to be placed in good repair. The second story is to be used by the Training School for Nurses, and the first floor as a Laboratory for the School of Clinical Medicine, with the understanding that the repairs are not to be made until we shall have available funds for that purpose; but, as will appear from another re-

negro hospital letter from Dr. J. J. Smith

Gentlemen:-

Referring to the matter under discussion with you to-day, I believe I voice the sentiment of most and probably all of the members of the Medical Faculty in recommending to you that you take measures to place the old negro hospital wards in thorough repair with the view of thus affording accommodation for the Nurses Training School and the recently authorized Laboratory of Clinical Medicine. The disposition of the nurses has been for the past year a matter of utmost question and concern, and it is absolutely essential that some provision be made as early as possible before the opening of the term. The Laboratory of Clinical Medicine is in the anomalous position that while it authoritatively exists and the requisite funds have been provided for its equipment, there is as yet no place in which to put such equipment when acquired, and there is no available space in any part of the college building for it. I can see no more available method of arranging for these two necessities. A number of members of the faculty, aware of the fact that these needs exist and thinking of such a solution of the difficulty, aware also of the lack of funds and the probable necessity for the revision of the special appropriations made for equipment purposes to the various chairs, several days ago were in conference. It was the consensus of those present (Thompson, Keiller, McLaughlin & Smith) that it would be wise to take as little as possible from the library appropriation and expressed themselves as believing it would be well to obtain the needed money by revision of the appropriations to the various chairs. If this be your opinion also, may I not ask for instructions to request the various members of the faculty from spending these appropriations before the next meeting of the Board?

That in pursuance of the suggestions of the Board of Managers of the Sealy Hospital, hereto attached (Exhibit A.), which have been carefully examined by us and approved, the said Board of Managers were authorized to contract for the erection of a brick building for a negro hospital on the north-west corner of the grounds, designated in said communication, for the donated sum of \$18,000.00, and that the building is to be constructed and said money expended under the direction of the Board of Managers of the Sealy Hospital, the same having been donated to them by philanthropic persons for that purpose, and that ^{neither} the Board of Regents nor the State ^{is} in ^{any} way responsible for the manner of the erection of said building.

2. That the said Board of Managers were authorized to commence work at once. This became necessary as the contract had already been let.

3. It was further considered that the wooden building heretofore used as a negro hospital be moved to the north-east corner of the grounds, giving place to the brick building to be contracted.

As Chairman of the Board of Managers of the John Sealy Hospital, I am authorized to present a communication explaining the existing conditions ~~on the Hospital Block~~ concerning the proposed erection of new buildings on the Hospital Block.

*Board Managers Sealy Hospital
 about Negro Hospital*

Through ignorance of the existing legal status of the Regents as "Governors" of the Sealy Hospital buildings and the land on which they ~~are situated~~ stand, the Hospital Board of Managers failed to notify the Regents concerning certain improvements about to be made. It is a matter of regret to the members that this occurred, and they wish it to be understood that they had no intention to usurp the "rights" of the Regents in this matter, but simply that the matter was not brought under their notice for action, and that the failure to notify resulted from ignorance as to its necessity. They hasten, therefore, to supply the necessary information, and to request the permission of the Board of Regents to proceed with the following improvements:-

The erection of a new brick Hospital for Negroes on the north-west corner of the hospital block. The amount of money available for this purpose is \$18,000 of which \$15,000 was donated from the North and \$3,000 from the Relief Committee of the City of Galveston.

The contract has been let after some difficulty, but has not yet been signed by the Building Committee. Since the receipt of your communication (verbally from the Dean) the Architect has received orders to suspend all further work and the contract is now in ^aobeyance until we hear from you.

As the contract has with much difficulty been let so as to be completed for the above figure we are very anxious to receive consent to continue.

The constitution of the Building Committee consists of two members from the Board of Managers, two from the Faculty of the University and one from the Relief Committee of Galveston City.

The building of the new hospital in this situation will necessitate the removal of the ambulance stable to another site. The ^{ambulance} ^{stable} east end of the present hospital block has been suggested, but others are available. As the removal of the stable is included in the contract, the site should be selected as soon as possible. The erection of the new hospital will not interfere with the present wooden building.

We beg respectfully that your body give permission for the above improvements to proceed as any interference with the existing contract might postpone for a number of months the erection of the hospital for the sum of money now in the hands of the Building Committee.

Gentlemen:-

I am authorized by the "Board of Managers" of the John Sealy Hospital to present to you the following facts.

1. That the Board has at its disposal the sum of \$18,000 to be expended in the erection of a hospital for the negroes.

2. That it proposes to erect such building of brick on the present Sealy Hospital block in the north-west corner if the "Regents" as Governors of the said property give the necessary permission.

3. The reasons for choosing this site are:- (1) that the cost of excavation will be much less there on account of a good foundation being found at a less depth. (2) The site is in less danger from overflow and destruction in the event of storms. (3) That the building is much more accessible and imposing in ~~the situation~~ this situation.

It is particularly requested that permission be granted to commence work as soon as possible as the contract cannot long be held in abeyance; and if the present contract were abrogated it would lead to endless delay to procure another contractor to carry on the work at the present price.

4. As ~~requested~~ ^{desired}, the present wooden building which was used as a "negro hospital" the Hospital Board would be glad if the Regents would take it in hand and use it to the best advantage. There is no money in the hands of the Hospital Board to fit this up for any purpose, and they wish to leave it in the hands of the Regents.

They would suggest, however, that ^{if} it be retained, it should be removed to the south-east corner of the present Hospital block so as to fall in line with the proposed colored hospital.

This site will then give good ventilation to both buildings and will improve the appearance of the present hospital yard. They respectfully suggest that the wooden building be removed as soon as possible in order that work may be commenced on the proposed brick building for the colored people.

The following opinion by the Attorney General was received by the Board: -
"Attorney General's Department,
State of Texas,
July 6, 1901.
Hon. Thomas S. Henderson,
Chairman Board of Regents,

"Dear Sir: I am in receipt of a communication from yourself, bearing date July 1st, 1901, in which you ask for an expression of the official opinion of the Attorney General, upon the question as to whether the Board of Regents of the State University of Texas have authority to acquire by purchase additional land for University purposes, - as for instance, the purchase of additional grounds on which to erect a gymnasium, and establish an athletic field for practice and instruction in physical culture for the students of the University, and in reply beg to answer: Art. 3843 of the Revised Statutes provides that the Government of the University shall be vested in a board of eight Regents, and Art 3846 provides that they (the Regents) shall establish the departments of a first class University; and the question as to whether or not a gymnasium and athletic field is a necessary department of a first-class University, is entirely a question for the determination of the Regents. Their determination in the matter is not subject to be reviewed by any other body. I therefore give it as the official opinion of the Attorney General's Department that the Board of Regents would have the power and authority to make the purchase inquired about.

End of report to the Board of Education, Oct. 17, 1901.

At a meeting of the Board of Regents held this day, regents Henderson (Chairman of the Board), Lawant, Bryan, Gregory, Spencer, were present.

The minutes of the last meeting of the Board were read and approved.

Judge Ramsey, of Johnson county, was allowed to appear before the Board in behalf of the payment of the balance of salary claimed by Dr. Leonard C. Dickson to be due him.

On motion of regent Lawant, it was ordered that the sum of \$5,187.50 be paid to Dr. Leonard C. Dickson as balance of salary from Sep. 15, 1899 to Sep. 15, 1900, he having already been paid to June 22, 1900, - at the rate of \$2,250 per annum.

The President presented the budget for the Main University in the light of the appropriation by the 27th legislature for the year 1901-1902. It was referred to the Finance Committee.

Resolutions prepared by the President concerning the adjustment of payment of salaries to the fiscal year ending August 31, 1901, were also referred to the finance committee.

The President read to the Board the report of the Director of the Mineral Survey (Wm. P. Phillips) for the months of August and September, 1901. (Said reports were kept by the President and not filed with the Secretary.)

The Mineral Survey was authorized to employ a man for two months at \$50.00 per month and his expenses paid to secure specimens of Texas fuel as set forth in the Director's report above mentioned report for September, 1901.

The Mineral Survey was authorized to publish bulletins on Texas fuel and asphalt.

The duties and powers of the Dean of the Law Faculty were defined as follows:

- 1st. To supervise the registration of students in the Department.
- 2nd. In absence of Dean of Academic Department to pass upon questions relating to academic requirement for admission into the Department.
- 3rd. To pass upon applications for advanced standing in the Department, in connection with the professors in charge of the several topics respectively, to determine credits to be allowed upon certificates from other Law Schools, to fix and announce the time and place of examination in Law topics of persons applying for advanced standing.
- 4th. To arrange the course of study for students not candidates for Degree.
- 5th. To prepare and submit to the Law Faculty a schedule of work for each year.
- 6th. To supervise the keeping of the records of the Department.
- 7th. In absence of the President to preside at the meeting of the Law Faculty.
- 8th. To deal in first instance in case of absence from exercises and neglect of work in the Department, and to make recommendation to the President concerning the same.
- 9th. To attend to such other administrative matters as shall be expressly committed to him by the President or Board of Regents.
- 10th. To study carefully the needs of the Department and the methods which obtain in other Law Schools, and to propose to the Law Faculty plans for the development and betterment of the Department.
- 11th. To report annually to the President the condition of the Department and the work being done and also the suggestions as to its future made to the Law Faculty and action of the Faculty thereon.

12 That said above mentioned duties and powers are to be exercised under the direction of the President.

It was ordered that the bill of Mr. Williams for \$652.23 be paid out of the Available University fund.

The following report of the Medical College Board was received, approved, and the recommendations therein adopted.

Report of Medical College Committee

Austin, Texas, October 18, 1901

To the Board of Regents,

Gentlemen:

A majority of your Committee on Medical College (Regent Brackenridge not being present) respectfully report that in the last week we have, in company with the Dean of the Medical College, and the President of the University, and the Contractor, carefully gone over the Medical College and Brackenridge Hall in Galveston, and inspected repairs made in said building pursuant to contract made necessary by the ravages of the great storm of September 8th, 1900, and we find the following to be the condition of affairs:

1st. That the contract is fulfilled and completed with the one small exception of sky lights for Anatomical Room, which is delayed without fault of Contractor, on account of not getting the glass in time. This item amounts to about \$500.00. We believe the work done by Contractor E. Tootill is in every way satisfactory and is ready for acceptance, and your Committee has ordered paid to the Contractor the balance due him, which was twenty-five per cent reserved except the sum of \$1,000. which we thought ought to be kept back as additional security together with the Contractor's bond of \$10,000 as guarantee that the sky lights would be placed in the Anatomical Room as above indicated.

Report of Medical College Board

We are pleased to be able to say that the condition and appearance of the Medical College and Brackenridge Hall are certainly as good, and we believe better, than before the storm of September 8th, 1900. For instance, these changes and repairs have permitted the calcimining of the whole interior of the College which had become dingy and was much needed. This calcimining gives the interior a new and agreeable appearance of neatness. The roof of the College has been changed by not restoring the ornamental part and by using red tiling instead of slate. Both these changes we believe have added to the architectural appearance and the safety of the building. A number of changes have been made in the College building by taking away inconveniences where they existed and adding conveniences which time and experience have shown to be necessary.

In due order and in detail, the following are the salient changes of note, to wit:

- 1st. The roof is now more compactly arranged and fitted up with sky lights in the Anatomy demonstration rooms, and in the East end and West end upper lecture rooms.
 - 2nd. Sloping water tight floors in Anatomy demonstration rooms in place of level floors which were not water tight.
 - 3rd. Six new private rooms under upper East lecture rooms for storage of lecture apparatus and illustrations for various Chairs. These rooms are entirely a new feature and space is utilized not heretofore used.
 - 4th. Arrangement of a dark room for Photograph work in connection with Chair of Pathology. This is an entirely new work and improvement. Out of the funds set aside by the Regents to the different Chairs for repairs in their several departments, a marked improvement is noted, a good deal of which will be in the nature of things permanent in the fitting up of the laboratories.
- The special items noted are as follows; to wit:
- 1st. Fitting up of Bacteriological Laboratory upon a good basis for class work in practical Bacteriology. The dark room above referred to.
 - 2nd. Fitting up of Laboratory of Physiology for practical work of class.
 - 3rd. Enlargement and much new equipment of Laboratory of Pharmacy.
 - 4th. Increase of space, utilization of Laboratory of Chemistry by doubling draws in Chemical tables and new equipment.
 - 5th. New equipment in Surgery, Obstetrics, Materia Medica, and

Physiology.

The Brackenridge Hall is completed and needs nothing added except the electrical lighting fixtures, which in some way was not called for in Architect Stowe's calculation and is omitted from the contract of Wm. Tootil the Contractor. This matter, since the last session of the Board of Regents was called to the attention of the President of the University by Dean Smith. The President referred the matter to Mr. Bryan, a member of the Medical College Committee, who alone of the said Committee was accessible, the other members, Messrs. Spencer and Brackenridge, being absent. Dean Smith requested immediate action, as delay could not be had in using the Hall. Mr. Bryan, for the Medical College Committee, under these conditions at once wrote Dean Smith authorizing the work to be contracted for and performed, but also informed him, Dean Smith, that some one would be held responsible for this failure to provide for putting in the electric lights.

At this point your Committee desires to call the Regents attention to the failure of Architect Stowe to provide for the electric lights in Brackenridge Hall in Galveston and suggest he be called upon for explanation. Also we ask the action of Mr. Bryan, acting for Committee, be ratified and the bill ordered paid as asked for by Dean Smith to Messrs. Sheets & McGraw of Galveston, Texas, which contract calls for \$149.00, and is hereto attached marked Exhibit "A".

Your Committee regrets to report that the work on the new negro wards to be erected on Sealy Hospital grounds just back of the Sealy Hospital on the Northwest corner by private donation of \$18,000, is not progressing at all satisfactory. Though contracted for more than three months ago and commenced two months ago, the first story is barely up, and the material used is not believed to be first-class but inferior. This work, however, is under the control of the Managers of the Sealy Hospital, and the member appointed to said Board of Managers, Dr. J. E. Thompson, by the Regents, seems to be alive to the defects in the Contractor's work, and he is trying to remove it, he informed your Committee. The Contractor for this building, which is to be a brick and three stories in height, is one McHenry of Galveston, Texas.

Report paid to regts page.

On the work of removing and repairing the old frame building used until recently for negro wards, your Committee reports that the Contractor McHenry is progressing very slowly. The building being still in its original location and being now braced for removal by ceiling and shingling before removed to the other side of the Sealy Hospital grounds, about 200 feet. The professors who expected to be in possession of their laboratories by the opening of the school, October 1st, 1901, were much disappointed over the tardy work being done by the Contractor. We regret we cannot inform the Regents when this very important work will be completed.

As matters of minor importance we report that we found no provision was made in the contract with Contractor Tootil for repairing the heating apparatus of the Medical College, and when it was tested while we were in Galveston, proved to be leaking in a number of places. These defects can be repaired at a small cost of \$15 to \$20, we are informed by the Provost, J. P. Johnson. Also we found no provision was made in the contract with Wm. Tootil for thoroughly repairing the porch of the Medical College. The only repair, it seems, called for was to stop certain leaks in the porch.

The Contractor informs your Committee the whole porch has sunk on one side, and needs extensive repairs, such as taking up and putting down new tiling on roof of porch and strengthening the pillars.

In conclusion we are glad to report that the attendance at the College this year promises to be as good as any year in the past. More than two hundred students have applied for admission, and it is confidently believed that by November 1st, which is the closing period for entrance to the Medical College, fully two hundred and fifty students will be matriculated.

Altogether your Committee report that the affairs of the Medical College are in a highly prosperous condition, and the outlook is good.

In accordance with the foregoing recommendations of the Medical Committee, the sum of one hundred and forty nine dollars was appropriated out of Medical College funds for the payment of the bill of Sheets & McGraw for lighting University Hall in Galveston.

Repairs. The repairs on porch and other unprovided for on Medical College building were referred to the Medical College Committee with power to act.

At a meeting of the Board of Regents held this day, J. S. Henderson, Chairman of the Board, and Regents Braasenkridge, Spencer, Bryan, Gregory were present.

The morning session was spent in consideration of University business, without any specific action being taken. Adjourned to 3 p. m.

The following report of the committee on buildings and grounds was presented by said committee and adopted by the Board:

To the Board of Regents:

Water Supply.

To find upon best information obtainable that it will require 3000 feet of a 12 inch cast iron water pipe together with some specials are necessary to make connections with the city water, and also the pipe as best to protect the buildings now upon the grounds, and also the present water a building, by enclosing the main building in a quadrangle. This, with special pipe and necessary lead, ditching, etc., we estimate to cost \$2000.00. A standpipe connected with this system, according to a bid made and submitted to the Board, will cost \$2,250.00, to which other contingencies will, in all probability, bring the cost up to \$4,000.00. In addition we should require at least 10 fire hydrants at a cost of \$100.00. It will require about 200 feet of 4-inch water, costing \$500.00 additional for these fire hydrants; then a 4-inch gas connecting stand pipe with University building 500 feet at a cost of \$250.00; great gas pipe valves probably \$200.00 to control the gas, \$200.00 for pipe distributing water for irrigation, leaving \$1,000.00 appropriation to meet the cost of buildings now in progress in construction.

Water Supply.

The committee, to whom was referred the subject of the proposed building, has to report that they are in favor of the matter, and submit to you, for our consideration, some plans suggested.
