MEETING NO. 1,159

FRIDAY, MARCH 24, 2017.--The members of the Board of Regents of The University of Texas System convened a special called meeting at 2:01 p.m. via telephone conference call on Friday, March 24, 2017, in the Board Room, Ninth Floor, Ashbel Smith Hall, 201 West Seventh Street, Austin, Texas, with the following participation:

In accordance with a notice being duly posted with the Secretary of State and there being a quorum present, Chairman Foster called the meeting to order in Open Session.

RECESS TO EXECUTIVE SESSION.--At 2:01 p.m., the Board recessed to convene in Executive Session pursuant to *Texas Government Code* Sections 551.071, 551.073, and 551.074 to consider the matters listed on the Executive Session agenda.

RECONVENE IN OPEN SESSION.--The Board reconvened in Open Session at 2:37 p.m. to consider the following actions on Executive Session items.

- 1a. U. T. Permian Basin: Discussion and appropriate action concerning individual personnel matters related to the search for a president, including discussion of candidates to be invited to interview

Regent Beck moved that the Board interview candidates for The University of Texas of the Permian Basin presidency at a future Board meeting as discussed in Executive Session. He said this motion is premised on the understanding that the names of finalists for the presidency will be made public at least 21 days before a vote to name a president.

Regent Longoria seconded the motion, which carried unanimously.

- 1b. U. T. San Antonio: Discussion and appropriate action concerning individual personnel matters related to the search for a president, including discussion of candidates to be invited to interview

Vice Chairman Hicks moved that the Board interview candidates for The University of Texas at San Antonio presidency at a future Board meeting as discussed in Executive Session. He said this motion is premised on the understanding that the names of finalists for the presidency will be made public at least 21 days before a vote to name a president.

Regent Aliseda seconded the motion, which carried unanimously.

- 1c. U. T. System: Discussion and appropriate action regarding individual personnel matters relating to appointment, employment, evaluation, compensation, assignment, and duties of presidents (academic and health institutions), U. T. System Administration officers (Deputy Chancellor, Executive Vice Chancellors, and Vice Chancellors), other officers reporting directly to the Board (Chancellor, General Counsel to the Board, and Chief Audit Executive), members of the Board of Regents, and U. T. System and institutional employees

- 2a. U. T. System Academic Institutions: Discussion and appropriate action regarding proposed negotiated gifts with potential naming features

- 2b. U. T. System Health Institutions: Discussion and appropriate action regarding proposed negotiated gifts with potential naming features
