#### MEETING NO. 950

MONDAY, APRIL 1, 2002.--The members of the Board of Regents of The University of Texas System convened at 4:22 p.m. on Monday, April 1, 2002, in the Beverly Ballroom B/C of the Hilton Dallas/Park Cities Hotel, 5954 Luther Lane, Dallas, Texas, with the following in attendance:
