About The Texas Child Mental Health Care Consortium

The Texas Child Mental Health Care Consortium (TCMHCC) was created by the 86th Texas Legislature in Senate Bill 11 (SB 11) to address gaps in mental health care for children and adolescents in Texas and to enhance collaboration across academic departments of psychiatry in Texas. Through the Consortium, Texas is provided a unique opportunity to implement evidence-based programs throughout the state through the collaboration of the state's many health-related institutions, state agencies, and nonprofits, building on the ability and success of existing programs at some of the institutions, developing new programs in conjunction with local school districts and local community mental health providers, and addressing the shortage of psychiatrists.

Essential Functions

The Texas Child Mental Health Care Consortium team is seeking a graduate or undergraduate student to help review and redesign the internal site used to communicate and collaborate with the 12 health related institutions we work with. In addition, a review and redesign of the external facing site is needed to keep up with the changing scope of the Consortium's work, ensuring content is tailored to our audiences and content easy to find.

Work expected to include:

- Conducting user experience research and interviews with external stakeholders
- Analysis of existing information sources / categories
- Developing a site architecture and user flow
- Creating a mockup of proposed site and gathering feedback to finalize design
- Working with senior staff on the development of the new site
- Completing user testing of the new site

Candidate must be able to work both collaboratively and independently.
