

- To set the expectation that our statutory obligations as peace officers shall be fulfilled and executed
- To identify emerging trends in public safety
- To support the institutions' law enforcement agencies with rapidly deployable special assets, advisors and resources
- To continually advance the science and delivery of police training and education
- To provide advice, counsel and guidance to institution police chiefs and their staffs

ODOP History



Created by the State of Texas Legislature in the wake of the active shooter event of August 1, 1966, The University of Texas System Police charter was to '...employ and commission peace officers for the purpose of protecting life and property...' at the campuses of The University of Texas System or wherever else U. T. interests or assets were represented or present. This decision was followed by the creation of the Office of the Director of Police and The University of Texas System Police Academy in 1968 and thus began the 50+ year legacy of which we are a part today.




ODOP History

U. T. System Police Academy



- Four full-time staff members
- Basic Academy 22 weeks
- 15 Consecutive Basic Academy classes passing State Peace Officer licensing exam at rate of 100% on first attempt
- In-Service Training

- Advanced Rapid Response Emergency Scenario Training (ARREST) including firearms simulator, use of force/ de-escalation, ambush and breaching training
- Advanced Officer Course 4 weeks



U. T. System Policy 170 – Oversight of Law Enforcement and Security for the U. T. System

ODOP Responsibility – Director of Police, Agency Administrator and Chief Law Enforcement Officer

- Texas Commission on Law Enforcement (TCOLE) considers the U. T.
 System Police as one state law enforcement agency made up of the Office of the Director of Police and 13 full-service campus police departments
- Law enforcement and security standards and practices, staffing levels, training requirements, professional qualifications, police academy, commissioning/revocation authority, inspections, System Rapid Response Team, administrative and criminal investigations, executive and special protection, major crimes team, counterterrorism, intelligence, crime analysis, command & control, promotional process, all police policy

- Advanced Rapid Response Emergency Scenario Training (ARREST) (Firearms Simulator, Breaching Training Platform) program matures
- Electronic/paperless Inspection Program established
- All Hurricane Harvey after action items completed
- Distribution of grant funded (\$561,000) Rifle
 Resistant Body Armor for all UT System Police
 Officers completed
- Continued to present "The Blueprint for Campus Police: Responding to Sexual Assault" nationally as a model practice for Law Enforcement
- Floodwater UTSP Response Boat Program established

- With the death of the incumbent Chief of the UTMB Police, ODOP Assistant Director Ruben Puente served as interim Chief of Police January-August 2018
- National search for Chief of Police, UT Medical Branch Galveston completed successfully
- Emergency Rescue Vehicle 2.0 operationalized
- All Criminal Justice databases (national & state) in operation
- Continue to enhance and build out Police Academy facilities through self-help and internal support
- Introduce Criminal Justice Facility Support Canine Program for victims


- Celebrated graduation of 100th Basic Police Officer Class
- Undertook state-mandated changes to Racial Profiling reporting requirements
- Recognized the 55 UTSP Officers who deployed during Hurricane Harvey response with the "Humanitarian Relief Award"
- UT System Police Academy showcased by the Texas Commission on Law Enforcement to visiting delegations of senior law enforcement leaders from Mexico
- Offer insider threat familiarization to institution Chiefs of Police

- Successfully coordinated and liaised with Metropolitan Police Department of District of Columbia on missing person from UT System Archer Center
- UTMB PD Officers were among initial first responders to active shooter event at Santa Fe High School in Galveston County and participated in the arrest of the shooter
- One UTMB PD officer was awarded the Medal of Valor for his heroism during the Santa Fe response and eight UTMB PD Officers were awarded the Distinguished Service Award for their actions during the response

2019 Initiatives


- Successfully advocate for competitive salaries, staffing and retirement options for our Police Officers

- Examine the application of drone technology in response to threats against institutions and public safety risks
- Develop enhanced standing doctrine/policy in response to active shooters
- Complete comprehensive review of all UT System Police policies to ensure currency and best practice compliance
- Pursue grant funding for radiation personal detection devices for all UTSP Officers

- Train for defending against complex coordinated attacks
- Select and implement the appropriate radio technology at ODOP to ensure statewide communications capability
- Continue to expand and deepen the UTSP capacity to detect threats, manage and assess risk and respond to armed intruders and active shooters
- Operationalize UTSP Floodwater Response Boat Program
- Ensure preparation of all intuition Police Departments for required conversion to Texas/National Incident Based Reporting System (T/NIBRS) for Crime
- Assist UT Health Science Center-Tyler
 PD with the planning for/ expansion of police services to UT Health East Texas facilities
