

## **ODOP Mission Statement**

#### **ODOP History**



Created by the State of Texas Legislature in the wake of the active shooter event of August 1, 1966, The University of Texas System Police charter was to '...employ and commission peace officers for the purpose of protecting life and property...' at the campuses of The University of Texas System or wherever else U. T. interests or assets were represented or present. This decision was followed by the creation of the Office of the Director of Police and The University of Texas System Police Academy in 1968 and thus began the 50+ year legacy of which we are a part today.



# **U. T. System Police Academy**

- Four full-time staff members
- Basic Academy 23 weeks
- 16 Consecutive Basic Academy classes passing State Peace Officer licensing exam at rate of 100% on first attempt
- In-Service Training
- Advanced Rapid Response Emergency Scenario Training (ARREST) including firearms simulator, use of force/ de-escalation, ambush and breaching training
- Advanced Officer Course 4 weeks





# U. T. System Policy 170 – Oversight of Law Enforcement and Security for the U. T. System

ODOP Responsibility – Director of Police, Agency Administrator and Chief Law Enforcement Officer

- Texas Commission on Law Enforcement (TCOLE) considers the U. T. System Police as one state law enforcement agency made up of the Office of the Director of Police and 13 full-service campus police departments
- Law enforcement and security standards and practices, staffing levels, training requirements, professional qualifications, police academy, commissioning/revocation authority, inspections, System Rapid Response Team, administrative and criminal investigations, executive and special protection, major crimes team, counterterrorism, intelligence, crime analysis, command & control, promotional process, all police policy

# **UTSP/ODOP Significant Initiatives & Events-2019**

- Conversion of Crime Data Collection from the FBI Uniform Crime Reporting System (UCR) to the FBI National Incident Based Reporting System (NIBRS)
- Development and Adoption of Formal UTSP Policy on Active Shooter Response
- Operationalization of FAA-compliant/TX DPScertified law enforcement drone program
- Comprehensive Review of all UT System Police (UTSP) policies (67) and Training/Advisory Bulletins (27)
- Undertake an Across the Board Study of Compensation for UTSP Officers
- High Impact UTSP Chiefs' Conference in Brownsville Hosted by ODOP and UTRGV PD Focused on Border Protection
- Successful Completion of Biannual Audit of the UTSP Academy by the Texas Commission on Law Enforcement (TCOLE)

- Deployment of UT System Police officers from every institution police department and the Office of Director of Police in support of the UT Permian Basin Police Department in the aftermath of the deadly Labor Day holiday weekend active shooter event in Odessa, a deployment in size equivalent to that which occurred for Hurricane Harvey
- Award of the UTSP Distinguished Service Cross (highest award that can be given) to UTSP Lieutenant for His Response to the Active Shooter Event in Odessa
- Successful Launch of ODOP Marine Patrol Program for Hurricane-Related Floodwater/Rescue Response
- Creation of Police Canine Kennels and Run at UTSP Academy
- Adoption of 40 Hour Crisis Intervention Training Block for the Basic Peace Officer Course



# UTSP/ODOP Significant Initiatives & Events – 2019 (continued)

- Successful Launch of Temporary Program to Monitor the Movement of Displaced Persons from Central America and Mexico to Border Cities Hosting our Campuses
- Implementation of Policy/Training Modifications Required by 86th Legislative Session
- The UT Medical Branch Galveston PD Marine Unit provided assistance to the US Coast Guard in June 2019 in a search/rescue /recovery operation involving a local fishing vessel and a passenger lost overboard/drowned in the Galveston Bay
- In January 2019 an Austin Cap Metro bus struck and killed a bicyclist on the UT Austin campus; UT Austin PD arrested and charged the bus driver with Manslaughter
